| Fire | Conforms to Queensland Fire Standards - fixed wire smoke detection, evacuation procedures, extinguishers, inspections & checks |
| Security | Lockable doors, duty management on call, authorised visitors, staff uniform, PGL staff presence, CCTV |
| Buildings | Comply with standard Facilities Management requirements e.g. fire, building regs, legionella, asbestos, emergency management plan |
| Catering | Complies with QLD Food Safety Program; encourage healthy diet |
